Subject:- Selection of candidates after operation of waiting list for the post of Followers (Migrant quota) in J&K Executive Police (Kashmir Province)

Reference:- i) Selection list issued by PHQ vide order No. 942 of 2019 dated 07-03-2019.

ii) IGP Kashmir Zone, Srinagar's Nos. Pers/Migrant-Rectt/2019/4769 dated 23-01-2020

Whereas, in terms of PHQ order No.942 of 2019 dated 07-03-2019 selection list in favour of 50 candidates as Follower (Migrant quota) in J&K Executive Police (Kashmir Province) was issued after completion of Recruitment Process carried out in the year 2018-19 and were subsequently adjusted in Kashmir Zone. Directions were issued to IGP Kashmir Zone, Srinagar for issuance of their formal appointment orders subject to fulfillment of prescribed formalities.

Whereas, the selected candidates were advised to present themselves in the office of IGP Kashmir Zone, Srinagar alongwith requisite testimonials for fulfillment of pre-requisite formalities prescribed for issuance of formal appointment orders within 21 days; and

Whereas, after the expiry of 21 days, directions were given to IGP Kashmir Zone, Srinagar to intimate the reporting/non reporting of selected candidates in their respective offices; and

Whereas, in response to PHQ directions, IGP Kashmir Zone, Srinagar has intimated that 09 candidates have not reported within stipulated time frame for joining. These 09 candidates have further sworn on affidavit that they are not willing to join against the posts for which selected; and

Whereas, accordingly, the selection of said 09 selected candidates was cancelled vide PHQ order No. 957 of 2020 dated 06-03-2020 on the recommendation of IGP Kashmir Zone, Srinagar; and

Whereas, consequent upon the above and considering the vacancies which accrued as a result of cancellation of selection of 09 candidates, the waiting list is operated to fill these resultant vacancies; and


Whereas, a candidate namely Sanjeet Singh S/o Kuljeet Singh R/o H. No. 340/22A Raipur Satwari Kashmiri Basti Beli Charana Jammu with D.O.B 08-05-1993 who stand selected under RBA category having secured 65 marks while operating the waiting list under OM category, being older in age than the next candidate in OM category waiting list (namely Popinder Singh S/o Attar Jeet Singh having D.O.B 10-12-1993), will jump from RBA category to OM category causing one vacancy in RBA category which has been filled by selecting the candidate next in order of merit in waiting list of RBA category; and

Whereas, During the recruitment process, 06 posts under SC category and 02 posts under ALC category remained unfilled due to non-availability of the candidates in these reserved categories. It is pertinent to mention that vide Government order No. 10-DMRRR of 2019 dated 06-03-2019, these vacancies can be filled from candidates of General category of the same recruitment process; and

Now, therefore, taking into consideration the above facts, the candidates mentioned in annexure "A" of this order are hereby selected as Follower in Executive Police (Kashmir Zone) from the waiting list subject to the fulfillment of following conditions/formalities:-

- i. Verification/authentication of the academic qualification certificates and other testimonials.
- ii. Verification of category certificate in respect of those candidates selected under respective categories in pursuance of SRO-294 of 2005 dated 21-10-2005 read with SRO 144 of 2008 dated 28-05-2008.
- iii. Verification of Character/antecedents from CID.
- iv. Medical examination/checkup from respective Police Hospital Kashmir/Jammu.

The candidates selected shall report to IGP Kashmir Zone, Srinagar alongwith their original testimonials within 21 days from the date of issuance of the appointment order failing which they shall forgo their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
