For and on behalf of the Governor of Jammu & Kashmir State, e-tenders are hereby invited from original manufacturers or their authorized dealers having authorization from the original equipment manufacturer to quote against this tender for supply of photography equipments required by Crime Branch Hqrs J&K under modernization of Police Force 2017-18.
