



20.	The BR Wind Screen Glasses delivered by the successful tenderer shall be surveyed and verified by the J&K Police at stores i.e. Police Central Stores Jammu, as the case may be.
21.	As soon as the acceptance of the tender is communicated to the successful tenderers online, the contract shall be binding on him. The earnest money of the tenderer who backs out or withdraw his tender or fails to abide by it after acceptance thereof is communicated/posted to him shall be forfeited besides other penal remedies that may be available to the Govt. of the J&K under the law for the time being in force in the State of J&K.
22.	The successful tenderer shall have to enter into an agreement on prescribed Proforma (immediately after the issue of supply order) with the Department for due performance of the contract which shall be furnished before the fabricated BR vehicles are delivered.

If at any stage of the tender process two or more bidders are found in collusion between/among themselves with intent to reduce competition, set price, share technical expertise, share business information/decision, control/share production and/or distribution of products and raise price, all such tenders shall be out-rightly rejected.
30.	If at any stage of tender process any bidder/s is/are found influencing any Government Servant associated with handling the tender process and supplies thereof, bid of such tenderer/s shall be rejected besides invoking any other provision available under rules.
31.	All legal proceedings arising out of any dispute between the parties shall have to be settled in the Courts situated in Jammu and Srinagar and not elsewhere.
32.	Supplies if deficient in any manner viz-a-viz supply order shall be rejected. Penalty/damages would be imposed and recovered from the bidder as per the terms and conditions indicated in the supply order.

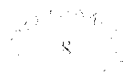



- 3 The approved supplier shall use superior quality of packing material.





3.	The rate tendered for supply of BR Wind Screen Glasses should be both in words and figures.																								
4.	The tenders should be filled in, neatly/clearly, with one ink.																								
5.	No alterations, over writings should be made in the tender.																								
6.	No conditional tender shall be accepted.																								
7.	The successful tenderer shall have to draw an agreement on prescribed proforma (immediately after the issue of Supply Order) and deposit 10% of the contract value, as security for the due Performance of the contract.																								
8.	The security money will be refunded after satisfactory completion of the agreed contract. No interest shall be paid by the department on such deposits																								
9.	The charges of stamp etc shall be paid by the supplier while executing the agreement.																								
10.	Payments shall be made by the purchasing officer against each consignment of BR Wind Screen Glasses, delivered, inspected/ accepted and properly taken on the stocks in the concerned stock registers of the department.																								
11.	Bank commission on payment made to the firm will be borne by the supplier.																								
12.	No advance payment shall be made.																								
13.	The approved tenderer has to deliver approved type/quantity of BR Wind Screen Glasses in Police central Store Jammu. After survey/acceptance of BR Wind Screen Glass supply, the firm has to fit BR Glasses into BP vehicles of J&K Police in Police Transport Workshop Jammu, in respect of the vehicles of Jammu Zone and in Police Transport Workshop Srinagar in respect of the vehicles of Kashmir Zone.

14.	In case of any dispute between the approved tenderer and the purchasing officer, the decision of the DGP J&K will be final and binding on the parties.
15.	In case the BR Wind Screen Glasses develops crack/or any other Manufacturing defect etc, during their Transportation/fitment, the loss there-of shall be borne by the approved tenderer.
16.	If after the registration/placement of orders, the tenderer backs out or fail to fabricate the vehicles, the security deposit will be forfeited, besides any other remedy that will be available to the department, under law in force, for the time being in the state.
17.	All the legal proceedings arising out of any dispute between the parties shall be settled within the territorial jurisdiction of J&K High Court.
18.	The approved firm shall not sublet the contract.
19.	The decision of the accepting authority shall be final with regard to the quality of fabrication.
20.	The stripped out material/BR Glasses of the BR vehicles should be accounted for, while quoting the rates.
21.	The successful Tenderers shall have to enter into an agreement with the department for successful delivery of BR Wind Screen Glasses. The approved tenderer shall have to indicate the warranty/ Guarantee of BR Glasses and certificate to this effect shall have to be endorsed on the body of the bill against which the vehicle is delivered to the department after conversion.
22.	The warranty period will be 03 years against manufacturing defects, delamination, poor visibility, development of air bubbles and other covering systems, sub-systems, after fitment of BR Glasses.
23.	The successful Tenderers shall have to ensure immediate fitment of BR Glasses, after successful test firing on BR Wind Screen Glasses at Police Transport Workshop Jammu and Police Transport Workshop Srinagar.
24.	The rates quoted by the tenderers shall remain effective for a period of one year from the date of issue of NIT.
25.	The authority /authorities will have full powers to accept or reject any tender or part, thereof, without assigning any reason and without any legal obligation
26.	The tenderer should furnish affidavit that his firm/company has not been blacklisted by the GOI, or any other state Government and that no any penalty, whatsoever, has been imposed on his firm by any Government department.
27.	The tenderer should be experienced Agency having already supplied BR Wind Screen Glasses to state Police forces/ PMFs and shall provide details/supply orders of supply of BR Glasses, executed from last 05 years, with Tender offer.
28.	To assist in the examination, evaluation and comparison of bids, the bidders may be individually asked for clarification of their bids.
29.	A copy of NIT duly signed and sealed (each page should be signed and sealed) by the Tenderer shall be enclosed with the Tender document, in token of having fully understood and accepted the terms and conditions of NIT.

30.	The Tenderer is required to furnish an authenticated copy of Tax Clearance certificate for the year 2017-18 or a year earlier. The PHQ shall be at liberty to scrutiny, verification etc the Tax clearance so furnished by the Tenderer.
31.	If at any stage of the tender process two or more bidders are found in collusion between/ among themselves with intent to reduce competition, set price, share technical expertise, share business information/ decision, control/share production and /or distribution of products and raise price, all such tenders shall be out-rightly rejected.
32.	The Department reserves the right to add or suitably modify the terms and conditions (without prior notification) as per exigencies and hence shall not be construed as all inclusive.
33.	The approved supplier has to arrange loading /un-loading of BR Glasses, at his own.
