

1. The Tender offer alongwith the sample should reach the office of ADGP HG/CD & SDRF J&K, ZPHQ Complex, Karan Nagar, Srinagar on or before 09-05-2018 upto 1600 hours positively. The tender should be addressed to ADGP HG/CD & SDRF J&K Jammu and envelopes should be super scribed "**Tender for Static Ropes for SDRF J&K**". The tender may be sent either by speed post/Registered Post/Courier or delivered personally at the Directorate of Homeguards/Civil Defence & SDRF, ZPHQ Complex, Karan Nagar, Srinagar against proper receipt.
2. The tender shall be opened on 11-05-2018 at 1200 hours at Directorate of Homeguards /Civil Defence & SDRF J&K Srinagar in the presence of such tenderers who may choose to be present. In case of any unforeseen/ unavoidable circumstances the tenders will be opened on next working day. The earnest money in shape of bank draft of Rs 10,000/- should be enclosed with the tender in absence of which the tender shall be liable for disqualification. The tender fee has been fixed as Rs 1000/- which should accompany the tender offer in the shape of a crossed demand draft favouring ADGP HG/CD & SDRF J&K Jammu payable at Srinagar/Jammu.
3. The rates should be quoted of all taxes, levis, freight, Transport & other charges to the place of delivery at Central Store HG/CD & SDRF Kashmir, at SDRF Ist. Bn. Hqrs., Bagat Barzulla, Srinagar. Quality/specifications should be categorically mentioned in the tender.

4. The undersigned will have full powers to accept or reject any tender without assigning any reason and without any legal obligation.
5. Payment shall be released by the department against each consignment delivered, inspected, accepted and properly brought on stock in the concerned stock registers of the Department.
