
1. Sealed tenders affixed with Revenue stamps of Rs. 6/= are invited on behalf of Director Sher-i-Kashmir Police Academy Udhampur for supply of following items / articles on annual contract basis for the year 2018-19.

2. Tenders are to be submitted on the prescribed form which can be obtained on application from Asstt. Director (Admn.) SK Police Academy Udhampur w.e.f. 10.02.2018 on payment of Rs.200/- (Rupees Two Hundred Only) in cash or money order which will not be refunded. Specification, size, sample, patent and quality etc. of the articles to be supplied and the terms and conditions of tender are available in the office of Director SK Police Academy Udhampur which may be seen / obtained by each tenderer before submitting their tender.
3. Tenders must be submitted in properly sealed double envelopes duly marked "Tenders for feed and fodder articles / items etc." addressed to Director S.K.Police Academy Udhampur and should reach this office on or before 24th of Feb.2018 upto 02 PM. The sealed tenders should be handed over personally at the above office and the receipt obtained or sent through registered post. The tenders will be opened by the committee or an officer duly authorized by the undersigned in the presence of suppliers / tenderers or their authorized representatives who may like to be present on 26th of Feb. 2018 at 1200 hrs.
4. Government (Director) is not bound to accept the lowest tender and may reject any tender or any part of the tender without assigning any reason.
5. Intending tenderers shall have to deposit earnest money of Rs. 25000/- (Rupees Twenty Five Thousand Only) in the shape of CDR pledged to the Asstt. Director (Admn.) S.K.Police Academy Udhampur without which tenders will not be accepted. The earnest money will be refunded to unsuccessful tenderers within one month of the final acceptance of the tender.
6. Rate should be quoted for the type of articles / items as mentioned above.
7. The rates quoted by the tenderers should be free from any cutting and overwriting. The rate should be written both in words and figures. In case of any confusion between the rates in figures and words, the rates written in words shall be taken as final.
8. The rates quoted by the tenderer should be inclusive of all taxes. No extra payment shall be made by the department.
9. The rates quoted should be covered by cello tape and are F.O.R. to S.K.Police Academy Udhampur. The tenders must be accompanied with sample of items to be supplied. The samples will be examined and approved by the technical committee to be constituted for the purpose. Only those firms which qualify the technical bid will qualify for the financial bid. The rates quoted by the lowest bidding firms will be approved.
10. The tenders must be accompanied with registration certificate of the firm.
