In partial modification of PHQ Advertisement Notice issued under endorsement No. Estt/Pros-12/2012/61457-610 dated 29.12.2012 regarding recruitment for the post of Prosecuting Officer(PO) in J&K Police, the revised eligibility criteria with respect to **Educational qualification** and **Age** are prescribed as under as a onetime exception in terms of Government order No.Home-195(P) of 2013 dated 22.05.2013:-

i) Educational Qualification	The candidate should have a minimum qualification of Bachelors Degree in Law from a recognized University after undergoing a regular course of study in Law for three years after graduation or five years after 10+2.
ii) Age (as on January 1st 2012)	Candidates should not be less than 18 years and not more than 37 years of age. (The candidates born before 01-01-1975 and after 31.12.1993 shall not be eligible).

2- There shall be, however, no change in the physical standards and other conditions which shall be the same as laid down in the earlier **Advertisement Notice**.

3- Further, it is notified that the candidates who have already applied in terms of the earlier Advertisement Notice and conform to the criteria prescribed in the said notice need not to apply afresh.
