The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about his character and antecedents is received from the Inspector General of Police, CID, J&K, to whom a reference shall be made by the Zonal IsGP alongwith verification rolls to be obtained from each selectee. Every selectee shall furnish an affidavit (**sample enclosed**) to the Zonal IsGP to the effect that in case any adverse report about his character and antecedents is received from the Inspector General of Police, CID, J&K, the selectee shall have no right to claim the appointment and his appointment as Prosecuting Officers in J&K Police shall be deemed to have been cancelled ab-initio.

IGP Kashmir/Jammu Zone shall get the candidates medically examined from regional Police Hospitals Srinagar/Jammu and this process shall be completed within the stipulated period of (15) days. On conclusion of the process IsGP shall despatch the selectees to SKPA Udhampur in Departmental vehicle on 16<sup>th</sup> December, 2015.

Director SKPA Udhampur shall prepare the service books of the recruit Prosecuting Officers and draw their salary after receiving their CID verification. To facilitate the drawal of salary equal number of vacant posts of Prosecuting Officers shall temporarily be attached with SKPA Udhampur from other units/wings by PHQ in due course of time.

This selection list is issued without prejudice to any SWP/ CMP/ LPA or any other matter pending adjudication in the Hon'ble High Court J&K. Pursuant to the directions passed by the Hon'ble High Court J&K, result of consideration in (03) cases has been kept in sealed cover.
