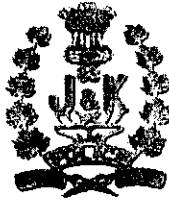

  - Candidate should bring all original certificates like State Subject, Date of birth, Degree Certificate, Valid Reserved Category (if any) alongwith marks

certificates for each of the examination passed for verification at the time of examination.

- d) Candidate shall also bring admit cards already issued to them at the time of written test.
- e) The candidates shall have to appear in the said examination at their own expenses.
- f) No request for change of Centre shall be entertained.
- g) Reporting time: 10:00 AM in case of candidates belonging to Kashmir province and 08:30 AM in case of candidates belonging to Jammu province on the schedule date of interview as indicated above.
