Whereas, among others, ASI (M) Manzoor Ahmad No.MEG911925 and ASI (M) Ab Hamid Thoker No. MEG832097 were also considered for being brought on promotion List "E" of the Cadre by DPC in its meeting held at PHQ on 12.10.2017.

Whereas after examining service records vis.a.vis clearance certificates from Vigilance Organization and CIV PHQ, DPC observed that although the prospective candidates obtained the requisite minimum qualifying marks alongwith others for release of promotion to the rank of SI(M), but owing to a communication from AIG(CIV) PHQ indicating that some complaints were pending against the duo, the DPC decided that their cases be reviewed on the disposal of the complaint and till such time, the DPC proceedings be kept in "sealed cover".

Whereas, the CIV, PHQ vide UO.letter No.01/NOC/NGO/CIV/PHQ/2017-11586 dated 10.11.2017 and UO. etter No.01/NOC/NGO/CIV/PHQ/2017-11882 dated 16.11.2017, has intimated that in both the cases allegations were not substantiated and the complaints were consigned to records.

Whereas, On receipt of report from CIV Section, the sealed cover proceedings were opened by the DPC and given to the clarifications as referred to above vis-à-vis earlier recommendations of the DPC, following two ASIs (M) in continuation of PHQ order No.3572 of 2017 dated 16.10.2017 are brought on promotion list "E" of the Cadre for

the year 2017 and accordingly promoted to the rank of SI (M) in the Pay Band-2 of 9300-34800+ GP 4240 with effect from 16.10.2017 i.e. the date their batch mates have been promoted as such:-

This order issues without prejudice to writ petition(s), if any pending in any competent court of law.


