C I R C U L A R

To extend timely assistance to the NoK's of Police personnel who sacrificed their lives in the line of duty, "Savera Scheme" was introduced at each District Hqrs under the supervision of concerned DYSP (DAR) as the Nodal agency.

Circulars have been issued from Police Headquarters for extending every possible assistance to the NoK's of Police martyrs but progress has not been satisfactory.


To strengthen the existing mechanism, it is hereby ordered that a cell consisting of one NGO and two lower sub-ordinates under the supervision of a GO be constituted at each District Police Hqrs. /Bn level Hqrs titled "Martyrs / Retired Police Assistance Cell". It shall function in addition to the existing Savera scheme to resolve the pending issues of NoK's of martyrs and issues of retired Police personnel. District SP/Commandants IR/Armed Bn's. shall issue orders for constitution of such cells under intimation to PHQ J&K.

Despite explicit instructions regarding timely settlement of Group Janta Personal Accidental Insurance claims of deceased Police Personnel, it has been observed that some claims are not being submitted to Nodal Officer Finance department J&K for early settlement, which adds to the miseries of aggrieved family

It is, as such, enjoined upon all DDO's of J&K Police to ensure that Group Janta Personal Accidental Insurance claims of Police personnel who die due to the accidents or militancy related incidents, supported with all pre-requisite documents, are sent to Nodal Officer, Finance department, J&K, as quick as possible. Since the matter is of prime concern, any deviation or inordinate delay in the submission of claims shall be the sole responsibility of concerned DDO.

Subject: - Prohibition of polythene bags in J&K Police Canteens.

CIRCULAR

It has been observed that polythene bags which are hazardous for health are being used in J&K Police Dry/Wet Canteens. The use of plastic material poses an environmental threat to natural resources.

To ensure effective implementation of J&K State Non-Bio degradable Material Act, 2007 and Hon'ble High Court directions in various PILs on the subject, the usage of the polythene bags should be stopped forth-with in all dry and wet canteens of the department.
