**Subject:-** Representation of Ex. Constable Mohammad Shafi No. 609/IR 3<sup>rd</sup> Bn for reinstatement.

This order disposes of the appeal/ representation preferred by Ex. Constable Mohammad Shafi No. 609/IRP 3<sup>rd</sup> Bn ARP-984601 for revocation of Order No. 864 of 2007 dated 29-10-2007 of CO IRP 3<sup>rd</sup> Bn. Brief facts of the case are as under:-

Whereas, Ex. Ct. Mohammad Shafi ARP-984601 (hereafter called as delinquent official) was appointed as Constable in IRP 3<sup>rd</sup> Bn. vide Order No. 248 of 1998 dated 08-06-1998 on probation for a period of three years.

Whereas, the delinquent official absented himself from duty w.e.f. 11-08-2007 and was accordingly informed through concerned Police station for resumption of duty. Despite repeated reminders the official neither resumed his duties nor anything was heard, for this grave negligence he was placed under suspension. A notice was also served to him through SHO Police Station Kangan as well as through special representative but again nothing was heard from his side.

Whereas, a final show cause notice was also published in leading Urdu News Paper "Srinagar Times" Oct. 23/2007 with the directions to appear in person within 07 days but he failed to do so. The delinquent official was provided fullest opportunities to mend his behavior but he did not cared and remained at large.

**Whereas,** keeping in view the above facts and non-compliance of orders, the delinquent official was discharged from services vide CO IRP 3rd Bn order No. 864/2007 dated 29.10.2007 w.e.f 11.08.2007 i.e the date he initially absented unauthorisedly.

**Whereas,** perusal of records of delinquent official reveal that during his short span of service he remained absent un-authorisedly from duty for about 40 times and was not proven to be an efficient police official instead has been lackadaisical and casual in his duties all along for which he has been suitably punished.

**Whereas,** in the light of the records pertaining to the case, it is worthwhile to mention here that the delinquent official remained silent since 2007 and after a gap of 10 years from the date of his discharge does not sound any reasonability nor does any plausible ground has been reflected which would invoke consideration.

**Whereas,** there is no force/cogent grounds in the claim of the representee and accordingly being devoid of merit/credible grounds, is rejected. The appellant be informed accordingly.





