Whereas, on the request of Addl. DG HG/CD/SDRF vide his letter No. Estt/5701 dated 22.06.2017, 15 SPOs were withdrawn from Armed Zone and allotted to SDRF vide PHQ order No.2922 of 2017 dated 04.09.2017 for their further deployment at Nehru Park Srinagar for Rescue Operations in Dal Lake ;

Whereas, out of these 15 SPOs, Following 3 SPOs working with Traffic Unit Srinagar were relieved by SSP Traffic City Srinagar vide his relieving order issued under endorsement No.Estt/SPO/17/162-67 dated 03.01.2018 with the directions to report to Commandant SDRF 1st Bn Srinagar:-

- 1) Sajad Hussain Bhat No.1406/SPO
- 2) Mehraj ud din No.1302/SPO
- 3) Khadim Hussain No.1411/SPO

Whereas, as per the DO.letter dated 04.06.2018 received from Addl. DG HG/CD/SDRF & Security, these 3 SPOs reported in SDRF 1st Bn next day i.e. 04.01.2018 and accordingly were deployed with Water Rescue Team of SDRF stationed at Nehru Park for rescue Operations in Dal Lake and are since then performing duties there invariably;

Whereas, the honorarium of these SPOs has to be drawn and disbursed by SSP Srinagar as the SDRF has no sanctioned /allotted position(s) of SPOs, as such, the Commandant SDRF 1st Battalion Srinagar vide letter No. Estt/SPO/2390-92/2018 dated 29.03.2018 forwarded the attendance of trio to SSP Srinagar for drawl of their monthly honorarium for the month of January to May 2018;

Whereas, SSP Srinagar vide order issued under endorsement No.Estt/SPO/F-20/2018/3667-76 dated 25.01.2018 dis-engaged these 3 SPOs while considering them to be absent since long;

Whereas, on the contrary, as per the communication of Addl. DG HG/CD/SDRF & Security (Do letter referred to above), these SPOs are performing their duties continuously with the Rescue team of SDRF stationed at Nehru Park Srinagar and the Addl. DG SDRF/HG/CD & Security J&K has strongly recommended the revocation of their dis-engagement order and release of their monthly honorarium;

In view of the facts and circumstances as enumerated above vis-à-vis while taking into consideration the recommendations made by Addl. DG HG/CD/SDRF & Security, dis-engagement order in respect of following 3 SPOs issued by SSP Srinagar vide endorsement No. No.Estt/SPO/F-20/2018/3667-76 dated 25.01.2018 is hereby set aside ab-initio, they be deemed to have continuously been existing on the muster rolls of District Srinagar and their honorarium may be released under rules:-

- 1) Sajad Hussain Bhat No.1406/SPO
- 2) Mehraj ud din No.1302/SPO
- 3) Khadim Hussain No.1411/SPO
