Whereas, notwithstanding the fact that PHQ is cadre controlling authority for Medical/Para Medical Staff and despite the explicit directions issued vide above referred to PHQ orders, APHQ vide order No.342 of 2018 dated 24.04.2018 effected transfers of following PMO/Para Medical Staff from and to the Units as indicated against each below:-

Whereas, the Medical/Paramedical Staff and those Police personnel deployed in different District/Unit MI Rooms, are under the direct administrative and management control of PHQ, and the transfers/adjustments in respect of this Cadre/police personnel are regulated centrally at PHQ;

Whereas, all the Medical/Paramedical Staff even Police personnel deployed in different District/Unit MI Rooms under PHQ orders, are not subject to displacement by any subordinate authority without the prior

approval of PHQ, non-adherence of which tantamounts to interference in the PHQ authority and trespassing over its prerogative ;

Whereas, in a similar move, the transfer order of Medical/Paramedical staff issued by APHQ vide No.598 of 2017 dated 11.08.2017 was rescinded by PHQ vide order No.3246 of 2017 dated 23.09.2017 and PHQ domain was unequivocally re-iterated, nevertheless, APHQ while not adhering the laid down procedure and explicit directions issued the impugned transfer order ;

In view of the aforementioned points, the transfer order issued by Addl. DG Armed in respect of above named five Paramedical Staff personnel and one PMO is hereby cancelled ab initio. However, he is advised to submit a proposal to PHQ with regard to the transfer of PMO(s)/Paramedical Staff/Police personnel deployed in MI Rooms to the PHQ for consideration of their transfers/postings on merit. Records of transferees who have changed their location pursuant to the APHQ order (now rescinded) shall be set right accordingly by the Commandants (DDOs) concerned who are also directed to furnish the report to PHQ directly with regard to the joining back of the above officials. Commandants (DDOs) shall not draw the pay of any of these officials who's transfer has been rescinded herein above and shall forward compliance report to this effect to CAO PHQ.
