Chapter-II (Part A)

Introduction

1.1 Right to information Act-2005.

An Act to provide for setting out the regime of right to information for the people of the Union Territory to secure access to information under the control of Public Authority, in order to promote transparency and accountability in the working of every public authority. Information under the Act means the information as defined in terms of Sec. 2 (f) of the Act. For complete copy of RTI Act-2005 please visit the website <u>https://rti.gov.in</u>.

1.2 Objectives/ purpose of Handbook:

The objective/ purpose of this handbook prepared under Right to Information Act-2005 is to keep the public informed about the Police Organization, its functions, duties etc. and to facilitate the public at large regarding the procedure etc. for seeking information pertaining to the Police Department which is otherwise not available in this handbook.

1.3 Who can use this Handbook:

Any person can use this handbook, as the same has been prepared for the information of public at larger under RTI Act-2005. The handbook can be perused on the official website of J&K Police (www. Jkpolice.gov.in)

1.4 Information of the Organization in this hand-book:

Jammu & Kashmir Police Organization.

1.5 Definitions:

The words and expressions used herein and not defined but defined in the RTI Act-2005, shall have the same meaning respectively as assigned to them in the Act.

1.6 Contact person in case somebody wants to get more information on topics covered in the hand-book as well as other information also:

1.7 Procedure and Fee structure for getting information not available in the Hand-Book.

- a) The procedure and fee structure as prescribed in Section 6 and 7 of the RTI Act-2005 shall apply mutatis –mutandis while seeking information from the Public Authority of the Police Department.
- b) A request for obtaining information, under Sub-Section (1) of section 6 of the RTI Act, 2005 either in writing or through electronic means in English, Urdu or Hindi as per the prescribed form (Form-A) shall be accompanied by an application fee of rupees ten by way of cash against proper receipt or by way of Indian Postal Order or demand draft or bankers cheque payable to the Chief Accounts Officer, (CAO) PHQ J&K.
- c) At the time of providing information, the fee as prescribed in sub Section (1) of Section 7 of the RTI Act, 2005 shall be charged by way of cash against proper receipt or by demand draft or bankers cheque payable to the CAO PHQ, J&K at the following rates:-
 - > Rupees 2/- for each page (A-4 or A-3 size paper), created or copied;
 - Actual charge or cost price of a copy in large size paper;
 - Actual cost or price for samples or models; and
 - For inspection of records, no fee for the first hour; and fee of rupees five for each fifteen minutes (or fraction thereof) thereafter.
- A fee shall also be charged for providing the information under sub Section (5) of Section 7 of the RTI Act, 2005 by way of cash against proper receipt or by demand draft or bankers cheque payable to the CAO PHQ, J&K at the following rates:
 - i. For information provided in diskette or floppy rupees, fifty per diskette or floppy; and
 - ii. For information provided in printed form at the price fixed for such publication or rupees, two per page of photocopy for extracts from the publication.

Chapter-II (Part B) Particulars of Organization, Functions and Duties.

2.1 Objectives/ purpose of the public authority.

EXECUTIVE

The command and control of the J&K Police vests with the Director General of Police, J&K, (DGP) who is in-charge of the entire gamut of Police Administration viz. recruitment, discipline, internal economy and administration in the UT of J&K. Besides being the head of the Police Department, the DGP, J&K is responsible for advising the Government on all matters connected with it. The J&K UT has been divided into two (02) Zones, Jammu Zone and Kashmir Zone, each headed by a Zonal Additional Director General of Police (ADGP) who is overall In-charge of law and order situation in the respective zone. The two zones are further divided into Ranges, each Range is headed by an officer of the rank of a Dy. Inspector General of Police (DIG). Presently, there are seven (07) Ranges, four (04) in Jammu Zone (Jammu-Kathua-Samba, Rajouri-Poonch, Udhampur-Reasi and Doda-Kishtwar-Ramban Ranges) and three in Kashmir Zone (Central Kashmir, North Kashmir and South Kashmir Ranges). The Range DIsG are supposed to supervise the police administration in all the Districts falling in their respective Renges, and the District is headed by an officer of the rank of Sr.Superintendent of Police (SSP)/ Superintendent of Police (SP). The Jammu Zone has ten (10) Districts (Jammu, Samba, Kathua, Udhampur, Reasi, Rajouri, Poonch, Doda, Kishtwar and Ramban Districts) while as Kashmir Zone has ten (10) Districts (Srinagar, Ganderbal, Budgam, Pulwama, Anantnag, Kulgam, Shopian, Baramulla, Bandipora and Kupwara) besides three (3) Police Districts viz. (Awantipora, Sopore & Handwara). The District SSsP/SsP are assisted by one or more Additional Superintendents of Police/ Asstt./Dy. Superintendents of Police in the discharge of their duties. To bring the police administration nearer to the people, Districts have further been divided into Sub divisions, Police Stations and Police Posts. The sub-Divisions are headed by officers of the rank of Assistant/ Deputy Superintendent of Police. Presently, J&K UT has 250 Police Stations and 180 Police Posts manned by Police personnel of the rank of Inspectors, Sub-Inspectors, Asstt. Sub-Inspectors, Head Constables, Selection Grade Constables and Constables as well as followers.

At the Headquarters of each district of J&K UT, an Armed Reserve (DAR) contingent under the charge of a Gazetted officer of the rank of Dy.SP to meet contingencies like leave/ sickness etc. and to perform other miscellaneous duties in the district like armed and unarmed guards, escort of treasuries, prisoners/ under trials and the like.

J&K POLICE HEADQUARTERS

All the policies aimed at direction an administration of the Police Department percolates from the PHQ under the command of the DGP J&K. At PHQ, the DGP J&K is assisted by 02 officers of the rank of Addl. DsGP (ADGP Headquarter and ADGP Coordination), 03 IsGP, Inspector General of Police (Headquarter/Technical, CIV), 02 DIsGP, (Deputy Inspector General of Police Administration/Trainings) 08 SSsP designated as Asstt. Inspector General of Police (Personnel), Asstt. Inspector General of Police (Crime Intelligence Vigilance), Asstt. Inspector General of Police (Provision & Transport), Asstt. Inspector General of Police (Welfare), Asstt. Inspector General of Police (Technical), Asstt. Inspector General of Police (Communication) and Asstt. Inspector General of Police (Buildings) who in turn are assisted by Dy.SsP and Section Officers to deal with various facets of administration, logistics, establishment and policy planning like:

- Recruitment, Promotions, Discipline, Internal economy and Administration in the force, Enquiries, Complaints and Appeals.
- Police purchases/ procurement.
- Buildings and Constructions The Police Headquarters has a Police Construction Division which is manned by an Executive Engineer who in-turn is assisted by Asstt. Executive Engineers and Jr. Engineers.
- Police Transportation.
- Training The Police Hqrs. is also charged with the responsibility of Training Induction, on-job and specialized trainings is imparted to Police Personnel to inculcate professional competence and acquire specialized skills required to handle any kind of situation. A State level Police Training Academy headed by an officer of the rank of Addl. Director General of Police (ADGP) is located at Udhampur with Police/Subsidiary training schools at Kathua, Talwara (Jammu Region) and Manigam, Lethpora and Sheeri (Kashmir Region) besides CTC Sujwan at Jammu under the Supervision of ADGP Armed. In addition, there is an intelligence and Security Training School at Vijaypur Jammu.

ARMED

The Armed Police is headed by an officer of the rank of Addl. Director General of Police. For effective supervision, the ADGP Armed is assisted by two (02) IsGP, (04) DIsG. The two IsGP exercise Superintendence of Armed/ IRP Battalions in their respective provinces (Kashmir / Jammu), each headed by a Commandant of the rank of SSsP/SsP and deployed in every nook and corner of J&K UT. There are at present (6) Armed and 24 IRP Battalions in the UT of J&K. The Armed Police deployed for multipurpose duties viz. Sanjy and other day-to-day duties related to security of District Hqrs. to deal with maintenance of law and order and combat militancy. The Armed Police is also utilized for manning vital installations vulnerable areas besides striking force to meet any eventuality.

SECURITY

The Security wing is supervised by an officer of the rank of ADG/ Inspector General of Police (IGP Security) who in turn is assisted by DIG Security and SSP Security at Headquarters. The Security wing is further divided into Security Kashmir, Security Jammu, Raj Bhawan, SSF, Civil Secretariat each headed by an officer of the rank of SSP. There are presently (5) Security battalions in the UT of J&K, each headed by Commandant of the rank of SSsP/SsP. The Security wing has the charter of providing security to protected persons, vital installations and to secure venues during sensitive events. The role of the wing has assumed more significance since inception of militancy in the State. Personnel of the wing are mostly deployed with various categorized protected persons for providing physical security to these PPs and their immediate family members besides providing fool proof protection to Hon'ble LG.

TRAFFIC

This wing is headed by an officer of the rank of Inspector General of Police (IGP) who in turn supervises the DIG and zonal SsP who are charged with ensuring the smooth flow of traffic at Jammu, Srinagar and the National Highway respectively. This wing is primarily engaged in regulating traffic and enforcement of traffic laws. With the unprecedented rise in the vehicular population across the UT particularly in twin cities of Jammu and Srinagar, the Wing is engulfed with heavy commitments in ensuring traffic regulation with meager manpower resources.

CRIME

This wing is headed by an officer of the rank of Special DGP who is assisted by a DIG and SSsP each at Jammu and Srinagar, in the discharge of his duties which include investigating cases of public importance, collection and consolidation of crime data, supervision of State Crime Records Bureau (SCRB), Crime Photograph Cell and

maintenance of Dog Squad. Two (02) Police Stations, one at Srinagar and other at Jammu under Crime Branch, have powers of investigation vested in them by the Government.

RAILWAYS

This wing has been carved out of erstwhile Crime and Railways J&K after Railways was made an independent organization in the aftermath of operation of railway traffic in the Valley. The Wing is headed by Addl. DGP who is assisted by one DIG Railways J&K besides SSP Railway Jammu, SSP Railway Kashmir and SSP Railway Katra. The Railway Police deals with criminal cases at Railway Platforms and tracks besides protection of Railway property.

HOME GUARD/ CIVIL DEFENCE/SDRF

This wing is headed by an officer of the rank of DGP J&K who is ex-officio Commandant General and assisted by Joint Commandant General of the rank of DGP designated as ADGP HG/CD/SDRF J&K. The ADGP/ IGP is further assisted by two (02) DIsG, who exercise command and control over Civil Defense/ Home guard and two SDRF (formerly Auxiliary Police Battalions) one each at Jammu and Srinagar which are headed by officers of the rank of SSsP/SsP. The SDRF discharges multifarious duties such as assisting the civil Police in traffic control/ regulation, maintenance of law and order and protection of life and property. The SDRF Bns. also organizes training of Civil Defense and Home Guard Volunteers to meet any eventuality and extend a helping hand during emergencies like natural disasters.

POLICE TELECOMMUNICATION

This organization is headed by an officer of the rank of IGP Technical Services who is assisted by an officer of the rank of DIG designated as Director, Police Telecommunication and assisted by technical personnel. The Director is responsible for installation, functioning and maintenance of Police Telecommunication grid in the UT linking Police Stations, Control Rooms, District Headquarters and other Police wings besides providing communication cover to the VVIPs.

POLICE HOUSING CORPORATION

There is an independent Housing Corporation called Police Housing Corporation (PHC) to execute construction works of J&K Police. The PHC is headed by a Chairman-cum-Managing Director who is assisted by Superintending Engineer, Executive Engineers, Assistant Executive Engineers and Junior Engineers. The Engineering staff of PHC is all on deputation to the Corporation.

CRIMINAL INVESTIGATION DEPARTMENT.

CID is the premier intelligence wing of J&K Police and has been traditionally occupying the important position by functioning as eyes and ears of the Government. The CID is headed by an officer of the rank of ADGP or IG and presently one Spl. DGP is heading the Wing. In the discharge of duties besides one IGP or DIG (as the case may be) and SSsP at Hqrs, he is assisted by two DIsGP CID Kashmir/Jammu who are assisted by SSsP Special Branch / Counter Intelligence in their respective provinces. While Special Branch is dealing with collection, collation and dissemination of intelligence relating to political and other counts to maintain the surveillance over the undesirable elements etc. The Counter Intelligence is basically an anti-militancy set-up dealing with the collection of intelligence to counter the threat of anti national, subversion, espionage, smuggling of contrabands and trans-border activities. Apart from these functions, the CID also carries out verification for the purpose of service, passports, threat perception, VISA clearance, NORI, migration relief cases and other allied verifications. SSP CID SB Kashmir/ Jammu are also designated as Foreigners Registration Officers in their respective jurisdiction. In addition, one SP is looking

after at CID Cell New Delhi which is responsible for maintaining liaison with Govt. of India and collection of intelligence having bearing on law and order, security and terrorist activities.

2.2 Mission/ Vision Statement of Public Authority.

The Jammu & Kashmir Police is scripting a saga of valour. It has met various challenges successfully, especially in the fight against terrorism and has upheld the honour of the organization and maintained the public trust. The J&K Police has emerged as one of the best forces in the country and is proud to have been recognized as a symbol of bravery by the central and the State Governments. Though our mission is to restore lasting peace and complete normalcy in the UT, but to deal with the day-to-day crime and law and order situations is our basic duty. We have to continue our fight against terror with full might and determination and at the same time serve the people of the UT with a renewed zeal to make Jammu & Kashmir a most peaceful and attracting UT in the country.

2.3 Brief history of the public authority and context of its formation.

In order to re-organize the police and to make it a more efficient instrument for the prevention and detection of crime, His Highness the Maharaja Bahadur in council vide State Council resolution No.CXII, dated 29th January, 1927, published in Government Gazette dated 22nd Chet, 1983, accorded sanction for the enactment of the Police Act, 1983 (1927 A.D) thereby repealing the Police Act No.1 of 1905.

Under the Police Act, the administration of the Police throughout the general police district was vested in an officer to be styled as Inspector General of Police. The Post of Inspector General of Police was subsequently up-graded w.e.f 25.05.1982 and as such, presently the administration throughout the general police district is now vested in an officer styled as Director General of Police.

2.4 Duties of the public authority.

The public authority is in-charge of the entire gamut of Police Administration viz. recruitment, discipline, law enforcement, internal economy and administration in the UT of J&K. Besides being the head of the Police Department, he is responsible for advising the Government on all matters connected with it.

2.5 Expectation of the public authority from the public for enhancing its effectiveness and efficiency.

Every citizen is expected to effectively feel concerned about the duties of the Police towards maintaining law and order, fight against the evil forces who are bent upon to disturb the peace and integrity of the UT and the Country, everyday crime etc. and help the Police in achieving the maximum, so that the society can be prevented from the evils and the evil forces in order to restore rule of law and lasting peace.

2.6 Arrangements and methods made for seeking public participation/ contribution.

Police Public meets are organized at quick intervals by the J&K Police just to make the general public aware about the Police working and garnering the public support/ participation in making the Police force more effective and efficient. Awareness through electronic and print media is also being generated amongst masses to spread the message of good governance, public participation and effective fight against the evil forces. To this direction, Civic Action Programs are being conducted/organized by J&K Police in order to have better relation with General Public.

2.7 Mechanism available for monitoring the service delivery and public grievance resolution.

All the important police numbers are made available on hoardings/ banners for the use of public. Public Meeting hours have also been prescribed so that people can meet the officer concerned and project their grievance. Every effort is made to redress the genuine grievances of the public as early as possible and result of the same is

communicated to them in order to secure the feedback. Police website at PCR level SMS Complaint service etc. are some of the other means.

Chapter-II (Part C)

Powers of Duties of officers and employees

3.1 That, all officers and employees of J&K Police derive their powers from the J&K Police Act 1927. The duties are discharged in accordance with procedures outlined in the J&K Criminal Procedure code and Police Rules as defined in the J&K Police Manual. In addition, the powers and duties of Police officers are guided by notifications, circulars and directions issued by the Government from time to time.

Chapter-II (Part D)

Rules, Regulations, Instructions, Manual and Records, for Discharging Functions.

4.1 That, all duties / functions are discharged by officers and employees of Police Department in accordance with existing Laws, Rules & Regulations and other Local and Special Laws of the land.

Some important functions discharged by the Department through its Officers and men include:-

· implementation of laws of the land , which are in force, in letter and spirit,

- · Criminal prosecution,`
- · maintenance of law and order,
- · prevention and detection of crime,
- · counter insurgency
- · allied & subsidiary functions and security related matters,

These functions necessarily have a social importance and are backed by provisions of various laws duly enacted from time to time. The various powers and duties exercised and performed are laid down in the Code of Criminal Procedure, the Police Act-1927, The J&K Police Manual, and various Local and Special enactments like Narcotic Drugs and Psychotropic Substances Act, Public Safety Act, Arms Act, Unlawful activity Act, Essential Commodities Act and all other Laws applicable to the UT of J&K to tackle specific situations. As regards the General Administrative Powers exercised in order to run the department, these powers are derived from various Rules and Notifications like the Police Act as applicable to J&K UT, J&K Police Rules, Civil Service regulations, Employees Conduct Rules, J&K Classification, Control and Appeal Rules, Leave Rules etc.

The J&K Police Manual exhaustively defines powers vested with various Police ranks and formations, including powers to be exercised for smooth functioning of the department like transfers, posting etc. and powers to be exercised in consonance and harmony with the Civil Administration and Judiciary. The latter includes duties to obey orders passed in judicial capacity by the Magistrates, laying of information before the Magistrates and execution of warrants issued in magisterial capacity either by the Executive or Judicial Magistrates. Powers of investigation and arrest are vested by the Code of Criminal Procedure whereby the field agencies are obliged to take cognizance of various offences committed within their local jurisdictions, investigate the same, and bring the same to the knowledge of Magistracy so that offenders are brought to justice under the laws of the land. A full fledged Prosecution branch functions within the Police Department to assist investigations & ensure speedy and effective trial of the cases before the Courts of Law. Powers of arrest are available in the Code of Criminal Procedure, mentioned in detail in the schedules to the CrPC. However, these powers are required to and are, exercised in conformity with the guidelines laid down by Courts of the Country.

A statement of boards, council, committees and other bodies constituted as its part.

5.1 The Police Department administers and monitors the functioning of the following boards, councils, committees and other bodies:-

1. Police Establishment Board.

Police Establishment Board is the prime decision making board in the matters of transfers, promotions, conversions, out of turn promotions, constituted by PHQ in compliance to the directions passed by the Hon'ble Supreme Court of India in case title Prakash Singh & Ors versus Union of India and Others.

2. Police Recruitment Board.

In order to conduct recruitment process in J&K Police more qualitatively and transparently, Transparent Recruitment Process (TRP) had been introduced for the first time in J&K Police in the year 2015 with the technical collaboration of an outsourcing firm (outsourced by the J&K Police Department) under the close supervision of Police Recruitment Board constituted by the Govt. of J&K Home Department on fast track basis covering all the phases involved viz. PET, PST, Written Test and preparation of Final Merit list, Selection and waiting list by the Police Recruitment Board with the help of latest computer technologies with minimum human intervention. Since, inception of Transparent Recruitment Process (TRP) system in Police department 05 recruitment processes for the post of Constables/ Sub-Inspectors have been successfully conducted in a smooth and transparent manner which have been widely acknowledged and appreciated by one and all in public. However, it is apt to mention that vide Govt. S.O 214 of 2021 dated 01.07.2021 all the recruitments up to non gazette level in J&K Police shall now be conducted by the JKSSB.

3. State Level Purchase Committee.

In terms of the powers conferred under the J&K Financial Code, a State Level Purchase Committee with ADGP (Hqrs) as its convener stands constituted. Procurement of provisioning/ Stores, supplies, Services etc. pertaining to the Department is regulated by the said committee.
