- IV. Health Certificate from the Police Hospital Jammu.
- V. Dependent Certificate issued by Assistant Commissioner Revenue.
- VI. All other relevant documents as are required under SRO-43 of 1994.

The appointment of Shri Gulzar Ahmed as "Constable" shall subject to the following conditions:

- a. That he shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the qualification certificates or any other certificate from the concerned issuing authority are found fake/forged, or if satisfactory report with regard to character and antecedents of the appointee is not received, the claim of the appointee for appointment as Constable in Executive Police shall be deemed to have been cancelled ab-initio and legal action warranted under rules shall be initiated against him.

- b. The formal appointment order in respect of the appointee shall not be issued unless a satisfactory report in respect of (a) above is received in his favour.
- c. The appointment of the candidate shall be governed by the New Pension Scheme as per SRO-400 of 2009 dated 24-12-2009.
- d. If the appointee fails to join within a period of 21 days from the date of issuance of this order, he shall forgo his right to appointment which shall be deemed to have been cancelled ab-initio, without any further notice.
