That she shall give an undertaking in the shape of affidavit to the effect that if , on verification, genuineness of the qualification certificates or any other certificate from the concerned issuing authority are found fake/forged, or if satisfactory report with regard to character and antecedents of the appointee is not received, the claim of the appointee for appointment as Follower in J&K Executive Police shall be deemed to have been cancelled ab-initio and legal action warranted under rules shall be initiated against her.
- b. The formal appointment order in respect of the appointee shall not be issued unless a satisfactory report in respect of (a) above is received in her favour.
