1. As recommended by the Board of officers, constituted vide PHQ order No. 932 of 2022 dated 16-03-2022, for conducting pre-selection tests in respect of in-service eligible candidates for induction/ absorption in Ministerial Executive Cadre as ASI(S), sanction is hereby accorded to the induction/ absorption of in-service Police personnel forming annexure "A" to this order as ASI (S) in the pay level-6 (35400-112400) with immediate effect.
2. The selection of the candidates shall be subject to verification, genuineness of their minimum education qualification viz Graduation. The concerned DDO's shall ensure that salary of the selected Personnel in the rank of ASI (S), be fixed/ drawn only after receipt of the verification report of the genuineness of the minimum educational qualification from the concerned quarters.
3. The lien and the seniority in respect of the selected candidates shall be deemed to have been terminated from their respective parent Zones/Wings/Cadres w.c.f the date of issuance of this order. Their future inter-seniority shall be determined in the Ministerial

Executive Cadre on the basis of their relative date of appointment/date of promotion, if any.

4. The adjustment order in respect of the selected candidates shall be issued separately by PHQ and they shall have to join at their places of adjustment within 21 days from the date of issuance of adjustment order, failing which the candidates shall forfeit right of his/her selection.

This order is issued without prejudice to the outcome of writ petition(s) if any, pending in the court of law.
