Subject:- Absorption of SPO as Constable in J&K Armed Police.

ORDER NO. 1243 OF 2023

D A T E D. 11 .04.2023

SPO Mohd Hussain Dar No.33/AROJ S/o Late Gh Qadir Dar R/o Singh Pura Kalan District Baramulla was recommended by the Range Level Screening Committee of Armed Police Hqrs, J&K through ADGP Armed J&K for his absorption as Follower under Sports category in pursuance to the Government Rehabilitation Policy.

Whereas, the case was accordingly processed at PHQ and as per bio-data of the SPO, furnished by the Range level Screening Committee of Armed Police Hqrs J&K, he was approved for the post of Follower in J&K Armed Police vide PHQ order No. 2988 of 2019 dated 30.07.2019 though he was fulfilling the eligibility criteria for his absorption as Constable; and

Whereas, ADGP Armed, J&K vide letter No. APHQ/Sports-31/2022/2755 dated 27.01.2022 has intimated that the case of SPO was examined/evaluated by the designated board under the chairmanship of IGP Armed/IR Jammu among others and was recommended for his absorption as Follower despite fulfilling all the required criteria for the post of Constable and requested that PHQ order referred to above be amended in respect of said SPO from Follower to Constable as he fulfills the criteria for the same; and

Whereas, the case was again placed before PEB for review of its earlier decision. The PEB after scrutinizing the record relevant to the case of the SPO as well as the recommendations has come to the conclusion that the claim of the SPO is genuine/justified and therefore, approved his case for absorption as Constable instead of Follower; and

Therefore, having regard to the PEB recommendations as well as conditions laid down in the Home Department's Policy issued under endorsement No.Home/PB-III/62/G/2008 dated 25.09.2009, SPO Mohd Hussain Dar No.33/AROJ S/o Late Gh Qadir Dar R/o Singh Pura Kalan District Baramulla be deemed to have been approved for his absorption as Constable in J&K Police on Sports grounds w.e.f 30.07.2019 instead of Follower.
