- 2. Only registered firms/agencies which are registered with Department of transport.
- 3. The tenderer must have experience in handling transport service at multiple location.
- 4. The bidder shall have to submit photocopy of 'existence certificate' of his firm.
- 5. The tenderer must submit photocopy of PAN number and service tax registration number of his firm.
- 6. Any other relevant document related to the provisions of transport services may be submitted.

# **Terms and Conditions**

# I. SERVICE PROVIDER'S RESPONSIBILITY

- 1. Prompt, Punctual, Efficient, Safe, Courteous and Quality are the essence of this short term tender.
  - 2. The service provided by the service provider should have valid registration certificate, full comprehensive insurance to cover third party and the occupants, vehicle fitness certificate, P.U.C, road tax, permit and any other relevant permits/licenses essentially required by RTO and other statutory bodies for operations of the SUV/load carriers and must be revalidated before the expiry of the due date during the tenure of the contract period.
  - 3. In the event of any delay or breakdown of vehicles, en-route, the service provider at his own cost shall make alternate arrangements for on-time pick-up of the officials.
  - 4. Logbook will be maintained for each car and it is the responsibility of the service provider or his representative to get the signature of the user promptly/daily.
  - 5. The service provider shall be personally responsible for any theft, dishonesty and disobedience by the drivers.
  - 6. During the contract period, if the vehicle is seized or detained by Police/Motor vehicle authority or any other authorities for any reason whatsoever: it will be at the contractor's risk.
  - 7. The service provider shall be solely responsible in respect of any claim, damages or other liabilities arising out of any incident/accident involving the vehicles deployed with him.
  - 8. The nature of duty to be assigned to each of the driver/vehicle shall be at the sole discretion of District Police Kishtwar.
  - 9. The service provider has to ensure the safety of officials by avoiding negligent driving by their drivers such as over speed, rash driving and driving vehicle with defective breaks or without brakes.

# II. SCOPE OF WORK AND CONDITIONS OF PERFORMANCE.

- a. If any vehicle is drawn out of service by the service provider for maintenance, repair etc, suitable alternate vehicle shall be required to be provided immediately by the Service Provider.
