Failure to comply with any of the conditions stipulated in the bid or instructions or the offer with insufficient particulars/documents shall lead to out-right rejection of the bid. If at any stage of the bidding process two or more bidders are found in collusion between/among themselves with intent to reduce competition, set price, share technical expertise, share business information/decision, control/share production and/or distribution of products and raise price, all such bids shall be out-rightly rejected. The fabricator hereby guarantees that the said BR vehicles would continue to conform to the description and quality aforesaid for a period as mentioned in the terms and conditions of Bid, from the date of acceptance of supplies by the purchaser. If during the aforesaid period the said BR vehicles are discovered not to conform to the specifications of supply order and quality aforesaid or not giving satisfactory performance or have deteriorated, the decision of the purchaser in that behalf shall be final and binding on the fabricator and purchaser shall be entitled to
- call upon the supplier to rectify/replace the defective parts or such portion thereof by the contractor and in such an event, the warranty period shall apply to the supplied BR vehicle/parts rectified/replaced from the date of rectification/ replacement thereof. In case of failure of the contractor to rectify or replace the defective parts etc within specified time, the purchaser shall be entitled to recover the cost with all expenses from the contractor for such defective parts etc by the available means.
- <u>Liquidity Damages:-</u> Successful Bidder shall have to deliver fabricated vehicles within 11. delivery period as would be mentioned in Supply Order. However, J&K Police reserves the right to impose liquidity damages as per Government of India guidelines i.e. @ Rs. 0.5% per week or part of week upto a maximum of 10% of the basic cost, excluding taxes, of depend upon the nature of supplies, extent of the unsupplied quantity which shall delay.

12. Fall Clause:-

- I. The price charged for the store supplied under the contract by the contractor shall in no event exceed the lowest price which the contractor sells the stores or offers to sell the stores of identical description to any person(s), organization(s) including the purchaser or any department of the Central Govt or J&K Government or any statutory undertaking of Central or J&K Govt., as the case may be during the period till performance of the contract.
- II. If at any time during the said period the contractor reduces the sale price or sells or offers to sell such stores to any person (s), organization(s) including the purchaser or any statutory undertaking of the Central or J&K Government, as the case may be, at a price lower than the price chargeable under this contract, he shall forthwith notify such reduction or sale or offer sale to the purchaser and the price payable under the contract for the stores supplied after the date coming into force of such reduction or sale or offer of sale shall stand correspondingly reduced.
- III. If at any time it comes to notice to purchaser that the contractor has sold the stores or offered to sell the stores of identical nature to any person(s), organization (s) or any J&K or Central Govt. department at a reduced price and has not notified the purchaser, the purchaser shall be at liberty to make the recoveries from the due payments of the contractor in case he fails to indemnify the purchaser on demand.
- IV. The contractor shall furnish following certificates to the paying authority alongwith the bills of payment:-

"I/We certify that there has been no reduction in sale price of the stores of description identical to the stores supplied to the Government under the contract herein and such stores have not been offered/sold by me/us to any person(s)/organization(s) including the purchaser or any department of the Central or J&K Government or any statutory undertaking of the Central or J&K Government as the case may be up to the date of the bill/the date of completion of supplies at a price lower than the price charged to the Govt, under the contract".

- 13. The exemption of experience/performance etc., if any as per the latest guidelines issued by Government of India and J&K UT Government for encouraging Start Ups/newly registered firm shall be allowed. Such firms need to attach necessary registration documents and copy of guidelines with their offer.
- 14. During the technical evaluation of bids, the concerned Committee will take into account relevant parameters and guidelines of GFR 2017 including recent insertion of Rule 144 (XI) in GFR 2017 issued by Ministry of Finance, Public Procurement Division vide Order No. 6/18/2019-PPD dated 23.07.2020.
- 15. The Code of Integrity clause as mandated vide rule 175 (1) & (2) of GFR 2017 is to be adopted by both the procuring authority and the bidder in letter and spirit. The bidders may refer CVC's communication No. 007/VGL/033/396514 dated 28.09.2018 for integrity pact.
- 16. No conditional bid will be accepted/entertained. It will be summarily rejected. No other condition than those mentioned (in the terms set-forth) will be entertained.
- 17. Purchaser reserves the right to get the manufacturing capacity of all the firms re-verified irrespective of the registration status or any other document/ information.
- 18. The BR vehciles supplied by the successful bidder shall be surveyed and verified by the J&K Police at stores i.e. Police Central Stores Jammu, as the case may be.
- 19. The bidder is required to furnish an authenticated copy of Tax clearance certificates (along with their offer or at the time of payments) for the year 2021-22 or a year earlier. The PHQ shall be at liberty to put to scrutiny, verification etc. the Tax clearance so furnished by the successful bidder.
- 20. If after the placement of orders, the bidder backs out or fail to supply the BR vehicles, the security deposit/EMD will be forfeited besides all other penal provisions the department may decide to impose as per existing norms.
- 21. The formal deed incorporating the terms of the contract will be executed by the successful bidder immediately after receipt of supply order. Failure to execute such bond/deed shall not however prevent the contract from being enforced against the bidder. Any loss sustained by the Govt. as a result of online bidding the contract shall be recovered from the defaulter, besides other penal provisions as the department may decide;
- 22. Bullet resistant vehicles shall be delivered (as per instructions in supply order) at Police Central Store, Gulshan Ground Gandhi Nagar Jammu as the case may be in perfect condition. The fabricator if he so desires may insure the fabricated vehicles against loss or theft, destruction, damages by the natural calamity loss by exposure to weather or otherwise viz. war rebellion, riot etc. The insurance charges will have to be borne by the fabricator and the department shall not pay such charges;

If the successful bidder fails to supply the ordered vehicles of the prescribed specification or fails to deliver the fabricated vehicles within the stipulated period as specifically mentioned in the supply order, the department shall be at liberty to arrange fabrication of vehicle from any other source or by re-bidding or otherwise at the risk and cost of the bidder. All legal proceedings arising out of any dispute between the parties shall have to be settled in the Courts situated in Jammu and Srinagar and not elsewhere. Supplies if deficient in any manner viz-a-viz supply order shall be rejected. Penalty/damages would be imposed and recovered from the bidder as per the terms and conditions indicated in the supply order. The fabricator shall not sublet the contract or any part thereof to any other agency without prior authorization of PHQ J&K. The decision of the accepting authority shall be final as to the quality of fabrication work and shall be binding on the fabricator. In case the fabricated BR vehicle is not according to specifications it shall be rejected and at our absolute discretion, rejected vehicle may be allowed to be made good by way of replacement. The loss caused due to rejection of the fabricated vehicles shall be entirely borne by the supplier. The department shall in no case be responsible for any loss or damage that may occur to the rejected vehicle/s while these are in the premises of the purchaser. Payments shall be made by the purchasing officer after fabricated/converted vehicles, delivered, inspected/ accepted and properly taken on the stocks in the concerned stock registers of the department. Bank commission on payment made to the firm will be borne by the supplier/ fabricator. No advance payment shall be made. In case of any dispute between the supplier and the purchasing officer, the decision of the DGP J&K will be final and binding on the parties The approved bidder/s shall have to indicate the warranty/Guarantee of BR Vehicle and certificate to this effect shall have to be endorsed on the body of the bill against which the vehicle is delivered to the department after conversion. The fabricator should furnish affidavit that his firm/company has not been blacklisted by the GOI, or any other state/UT Government and that no any penalty, whatsoever, has been imposed on his firm by any Government department. The department will impose penalty (on GeM rates) on the approved supplier, if the BR material arranged by the fabricator for fabrication of vehicles fails in the test fire, causing delay to

complete the fabrication, within delivery period on this account, as the time to be consumed in
