## ORDER

Subject:- Blacklisting of M/S S.Aditya Impex Pvt Ltd B-534, Sushant Lok-1, Gurgaon-122002

- Whereas PHQ floated bid nr GeM/2022/B/2036487 dated 13.03.20222 for procurement of 35 nrs K4 & K8 crash tested Blocking Bollard to be installed at a vital installation viz Raj Bhawan Srinagar, and Jammu.
- 2. Whereas among others M/S S.Aditya Impex Pvt Ltd participated in the bid and emerged as L1 firm.
- 3. Whereas demonstration arranged by the firm at Rao Tula Ram Marg, RK Puram New Delhi was witnessed by the committee headed by Deputy Inspector General of Police, Range Srinagar and during demonstration the committee has raised some observations of the offered item. PHQ J&K shared the observation of the committee with the firm M/S S. Aditya Impex Pvt Ltd with the request to provide undertaking that the firm would provide product conforming to bid specifications.
- 4. Whereas firm furnished undertaking to PHQ J&K that the firm will provide product conforming to bid specifications at the time of supply of the item.
- 5. Whereas it was decided that firm shall install blocking bollard at actual site i,e Raj Bhawan, J&K and after completion of installation, the committee headed by Deputy Inspector General of Police, Range Srinagar shall witness demonstration of the site and if found as per specification of the bid, then the firm will be given supply order of whole quantity and accordingly the firm was asked to install/commission item within a period of 30 days.
- 6. Whereas, the firm intimated that it will not be possible to install blocking bollards at Raj Bhawan J&K site but the firm can arrange demonstration at their office at Gurgaon Delhi. PHQ agreed with the request of the firm and asked to install item at their office premises at Gurgaon within 15 days for demonstration purpose.
- 7. Whereas on completion of the installation, the committee headed by DIG CKR Srinagar with members visited Gurgaon, Delhi and again the item was not found as per specification of the bid.
- 8. Whereas ticket nr 1631638 dated 10/07/2023 was raised on GeM against the firm and showcase notice was served to the firm through GeM.

- 9. Whereas on the request of M/S S.Aditya Impex Pvt Ltd a consultative meeting with regard to dropping of incident on GeM was held on 14/08/2023 through VC with the representatives of the firm. During meeting various points were discussed and the firm did not convince the participants to drop the incident.
- 10. Whereas GeM authority suspended M/S S.Aditya Impex Pvt Ltd for period of two months with effect from 09/08/2023 08/10/2023.
- 11. Whereas the firm M/S S.Aditya Impex Pvt Ltd has wasted precious 490 days time of the department and caused loss to Govt exchequer.
- 12. Therefore in view of above facts it is ordered that:

M/S S.Aditya Impex Pvt Ltd B-534, Sushant Lok-1, Gurgaon-122002 is hereby blacklisted for a period of one year from the issuance of this order.
