In addition to the above tasks, for streamlining of records observations if any which have arisen at any point of time on account of reconciliation/ differences in the bank/ ledger records have to be addressed also. Moreover, the rectifications/ observations to the different account heads emerged from time to time to the relevant accounts (i.e, from S.No. 01 to 10 of J&K Police Weifare Fund Accounts to be brought under ledger specifications) have also to be resolved/ rectified in accordance with the bank/ ledger records. The concerned Auditor shall be bound to ensure identification of reconciliation differences of clarification entries under proper printed format.

## TERMS AND CONDITIONS OF THE AUDIT:

1	The chartered Accountant Firm should be the Member of Association of Chartered Certified Accountants (ACCA)
2.	The Firm has to submit self-certified copy of valid Pan Card of the Firm.

3.	The Firm has to submit self-certified copy of GST Registration Certificate.
4.	The Firm has to submit self-certified copy of empanelment letter of Comptroller and Auditor General of India (CAG).
5.	The Firm has to submit self-certified copies of the IT Returns of the Firm/full time partners/Sole proprietor / others as the case may be for the last three years.
6.	The CA Firm must have their Head Office or Branch office in Jammu or Srinagar. The Firm has to submit self-certified copy of ownership of Office/ Rent agreement with electricity bill as proof. The Firm shall ensure that their services are readily available at all times to PHQ J&K even after completion of audits so that discrepancies, misinterpretations & other relevant issues are logically discussed for clearance.  PHQ Jammu/ Srinagar shall not bear the expenditure on travelling, boarding lodging etc. of the staff deputed by the Firm for auditing purposes or for representing the PHQ before any official authorities in connection with settlement of account for the year under review.
7.	The Firm shall submit an affidavit to the effect that they have neither been blacklisted not debarred by any authority.
8.	The Firm should have at least 5 years experience in Finance, Banking and Management.
9,	The Firm should have ability to interpret figures and information, strong analytical and problem resolving ability
10.	The Firm shall have to sign a service agreement on non judicial stamp paper worth Rs.100/- duly attested by Executive Magistrate.
11.	The successful bidder will have to deposit security amount of Rs.30000/- (Rupees thirty thousand only) in the shape of CDR/FDR pledged to AIG(Welfare) PHQ valid for three years or up to the completion of the assigned tasks. The security deposit shall be refundable after receipts of the audit reports and relevant tasks.
12.	The bids submitted by the Firm should be unconditional. Conditional bids shall be summarily rejected without assigning any reasons.
13.	The accounts and allied work shall have to be completed in a phased and time bound manner giving the maximum time of 1-1/2 months for the financial/ account year. The Firm has to execute a proper agreement with AIG(Welfare) PHQ for time bound delivery of Accounts/Balance sheets of each fund accounts as well as cumulative or consolidated pertaining to the respective societies, concurrent audits and other reports.
14.	The Audit exercise shall be carried out at Police Headquarters and respective units during the working days.
15.	The Firm shall solely be responsible and liable for penal action/ forfeiture of security deposit(s)/ Audit fee charges in the event details of accounts are leaked out, provided to public or private agency whatsoever

	penalty from 5 to 10% of tendered amount shall be imposed for the
