- The System shall have 30 or more discussion devices (DDs) per control unit, which means it can have more DDs as per departmental requirement (expandable to 40 or 80 DDs).
- The HD Camera Control (for Video Conferencing) shall be supporting maximum 06 high definition IP cameras. It can be achieved only with the help of additional equipments like NVR, switches, Memory Devices etc.
- 3. Digital Acoustic Feedback Suppression (DAFS) is a function in which the mobile phones on silent mode only cannot interfere with the PA system when a person is close to it. This means DDs are GSM immune. This feature is very important in present scenario as otherwise the participants have to switch off their phones during a meeting.
- 4. The specifications recommended for speakers in the tender are appropriate which are supposed to be inbuilt for all DDs.
- Although the HDMI and Lapel extension cables were earlier mentioned without quantities, the requirement of these may be considered as per cost per meter.
- The Cable Cubby (Cable Management box for easy power point presentation etc) which in itself is incorporated with the interfacing units like LAN, HDMI, Power, VGA and Audio.
- 7. There is no requirement for additional controller for DDs for the system as the inbuilt controller in the system shall suffice the requirement.
- 8. The Miscellaneous row in BOQ is being kept, in case, if the department has to make any addition in the components after the tender is floated, which is intimated to the intending bidders by floating the amendment subsequently.
