

Executive Engineer PCD PHQJ&K JAMMU/SRINAGAR on behalf of The President of India invites tenders by e-tendering on **Percentage rate basis** from approved and eligible contractors registered with J&K Govt. / CPWD / Railways and other State / Central Governments for the following works.

1. Date of Publishing 16-12-2023 at 1600 hours.
  2. The Bidding documents can be downloaded from the website <http://jktenders.gov.in> from 1630 hours on 16-12-2023.
    - i. The Bids shall be deposited in electronic format on the website <http://jktenders.gov.in> from 16-12-2023 to 22-12-2023 upto 1600 Hrs. The bids received will be opened at 1100 hours on 23-12-2023 on line.
    - ii. The complete bidding process will be on line.
    - iii. Technical bids of bidders shall be opened on line in the office of **Executive Engineer PCD PHQ J&K Jammu/ Srinagar** on 23-12-2023 at **1100 Hrs.**
  - iv. The lowest bidder i. e. L1 shall be intimated to deposit the original copy of required earnest money in shape of CDR/ FDR and hard copies of all relevant documents as mentioned in clause 2 of general instructions to the bidders within five days from opening of financial bids.
  - v. In light of Govt. Notification issued by Finance Department Civil Secretariat Vide No. A/24(2017)-651 dated:- 07-06-2018, the bidder must upload the copy of challan / receipt on account of cost of tender documents remitted in the treasury concerned for that the bidders must write an application to be addressed to treasury officer concerned requesting therein for remittance of amount as cost of tender documents towards M. H. 0055/ Revenue (others).
  - vi. The cost of tender documents should be submitted by the bidder in shape of treasury challan / receipt and upload the same.
3. **Earnest Money:-** The earnest money deposit (EMD @ 2% of advertised cost) in the shape of CDR/FDR pledged to Executive Engineer PCD PHQ J&K Jammu/ Srinagar of the successful bidder (L1) shall be released, only after defect liability period, the DLP shall be calculated from the date of successful completion of the work to the satisfaction report of Engineer incharge.
  4. Bid documents can be seen at and downloaded from the website <http://jktenders.gov.in> Bid documents contain qualifying criteria for bidder, specifications, bill of quantities, conditions and other details.
  5. The site for the work is available. The intending bidders are strongly advised to inspect the site of work before bidding.

6. Financial Bids will be opened on line in the office of the **Executive Engineer, PCD PHQ J&K Jammu/Srinagar**. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. The bid for the work shall remain open for acceptance for a period of **90 days** from the date of opening of bids. If any bidder / tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
8. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without permission of the Government. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's Service.
9. Other details can be seen in the bidding documents.
10. **Instruction to bidders regarding e-tendering process.**
  - i. The interested bidder can download the NIT/bidding document from the website <http://jktenders.gov.in>
  - ii. To participate in bidding process, bidders have to get (DSC) "Digital SignatureCertificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
  - iii. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
  - iv. Bids will be opened online as per time schedule mentioned in Para 2(III).
  - v. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
  - vi. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
  - vii. All the required information for bid must be filled and submitted online.
  - viii. Bidders can contact the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.
  - ix. Original Registration certificate of GST No. shall be uploaded on line.
11. The guidelines for submission of bid online can be downloaded from the website <http://jktenders.gov.in>
12. No construction material shall be supplied by Police Construction Division, PHQ. However; the brands of the material will be approved by Engineer In-charge of the concerned site in consultation with Executive Engineer, PCD PHQ J&K.
13. In case of any typographical error, if found in the rates or units etc. the same shall be corrected and paid as per sanctioned schedule of rates 2022/LMR with contractor's Tender appreciation/depreciation.
14. Any item of work not advertised in the rate list but found necessary during execution of work should be got approved by the competent authority before proceeding further beyond the

- allotment and payment for the same shall be made on sanctioned schedule of rates 2022 and LMR with contractor's overall appreciation/depreciation.
15. In case of delay in completion of the work beyond schedule period of completion (as per allotment), a penalty at the rate of 1% per month (on pro-rata basis) on the amount of allotted work shall be imposed on the Contractors subject to a maximum of 10% of the contract value.


