- 1. Offer should be accompanied with the following documents (self attested with seal)
 - a. Valid Tourism Registration Certificate mentioning therein registered number of rooms with Tourism department.
 - b. GST number.
 - c. PAN Card.
 - d. Sixteen digit Bank Account No. of Registered Hotel/ Proprietor.

Note: - Any offer without above mentioned pre-requisites shall not be entertained.

- 2. The offer shall specifically mention the floor wise room Nos. intended to be offered.
- 3. The offer must be put in properly sealed envelope strictly as per the conditions given in the offer.
- 4. The Hotel/Guest House/Lodge owners shall sign each page in token of the acceptance of terms & conditions.
- 5. Halls of Hotels/Guest houses/Lodges are not required by the department.
- 6. Conditional offers are not acceptable.
- 7. Every room offered shall have adequate furniture viz .02 chairs & 01 Table/furnishing/hot water facilities by way of geyser/boilers and television installed.
- 8. Hotel/Guest House/Lodge owners shall ensure cleanliness/ change of linen viz bed sheet, pillow covers on every weekend.
- 9. Hotel/Guest House/Lodge owners shall ensure daily housekeeping of rooms and bathrooms. Besides, ensure necessary sanitary items viz Towel, Mirror, Hand wash, Toilet cleaner & Phenyl also be placed in bathrooms.
- 10. Hotel/ Guest House/Lodge owners shall ensure to provide adequate parking slots to occupants.
- 11. The hiring of Hotel/Guest House/Lodge can be repudiated at any time if the services are not made to the best satisfaction of the allottees/department.
- 12. The Hotel/Guest House/Lodge shall be hired after inspection by the team of officers constituted by the PHQ and subject to clearance by the Security Agency.
- 13. The room rent will be paid by the Department as per approved rates of the Govt.
- 14. The Hotel/Guest House/Lodge owners shall ensure that proper power supply shall be made available with availability of Generator, in case of power failure.
- 15. DGP J&K reserves the right to accept or reject any offer/all offers without assigning any reason thereof.
- 16. In case two or more complaints are received against the Hotel/Guest House/ Lodge and the same numbers of notices served to the Hotel/Guest House/Lodge, the Hotel/ Guest House/Lodge will be de-hired without further notice.
- 17. Taxes as applicable under rules shall be deducted from the bills of the hoteliers.
- 18. The Hotel/Guest House/Lodge owners shall install Fire Extinguisher (floor wise) in the Hotel/Guest House/Lodge.
- 19. The Hotel/Guest House/Lodge owners shall install CCTV cameras at the reception/nain entrance of the Hotels/Guest House/Lodge.
- 20. The Hotel/Guest House/Lodge owners having tourism registration upto 10 room, 20 rooms, 30 rooms and above shall install at least 01,02 and 03 Nos. of water purifiers respectively in their Hotels/Guest Houses/Lodges.
