successful bidder (L1) shall be released, only after defect liability period, the DLP shall be calculated from the date of successful completion of the work to the satisfaction report of Engineer in charge.

(The date of Treasury challan/ EMD should be between the date of start of bid submission and bid submission end date).

- 5. The site for the work is available. The intending bidders are strongly advised to inspect the site of work before bidding.
- 6. Financial Bids will be opened online in the office of the Executive Engineer, PCD PHQ J&K Jammu/Srinagar. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7. The bid for the work shall remain open for acceptance for a period of **90 days** from the date of opening of bids. If any bidder / tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 8. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without permission of the Government. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's Service.

- 10. Instruction to bidders regarding e-tendering process.
  - i. The interested bidder can download the NIT/bidding document from the website <a href="http://jktenders.gov.in">http://jktenders.gov.in</a>.
  - ii. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above mentioned digital certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificates, need not to procure new Digital Signature Certificate.
  - *iii.* The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No Proposal will be accepted in physical form.
  - iv. Bids will be opened online as per time schedule mentioned in Para 2(III).
  - v. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
  - *vi.* The department will not be responsible for delay in online submission of bids whatsoever reasons may be
  - vii. All the required information for bid must be filled and submitted online.
  - viii. Bidders can contact the undersigned for any guidance for getting DSC or any other relevant details in respect of e-tendering process.

- 15. In case of delay in completion of the work beyond scheduled period of completion (as per allotment), a penalty at the rate of 1% per week (on pro-rata basis) on the amount of allotted work shall be imposed on the contractors subject to a maximum of 10% of the contract value.
