## **NOTICE**

Subject:- e-NIT No. 23 of 2019 dated 25.04.2019, floated for bullet-proofing of Land Rover.

Police Hqrs. J&K received some observations/queries from intending Tenderers with regard to e-NIT no. 23 of 2019 dated 25.04.2019, floated for bullet-proofing of Land Rover. A report on the said observations/queries has been obtained from the Technical Committee constituted by PHQ J&K for the purpose.

All the intending Tenderers are hereby notified about the outcome report, which is mentioned below. The said report shall mutatis mutandis form part of the said e-NIT and deemed to be an amendment to the e-NIT wherever applicable. The other terms & conditions of the e-NIT shall remain unchanged.

- 1. <u>Alternate Warranty/Guarantee:</u> The Alternate Warranty/Guarantee for the base vehicle must be covered by the fabricator for all the damages or technical flaw, if any, which will arise during or after the fabrication process.
- 2. <u>Providing of road-worthy Certificate:</u> The road-worthy Certificate is to be provided by any agency which is authorised to do so under GOI norms.
- 3. Number of vehicles to be bullet-proofed: Police Hqrs. J&K has already purchased one Land Rover Discovery 3.01 Diesel 4WD, which has to be armoured.
- 4. <u>Tyres:</u>- Hardened Rim rubber coated Tubeless Tyres has to be provided to the BR vehicle.
- 5. <u>Smoke Screen</u>: Smoke screen is part of vehicle visibility. It is a cover of smoke generated/produced if the vehicle comes under attack from outside by anti national elements.
- 6. <u>Paint</u>: The BR vehicle has to be painted with fire resistant paint. The existing colour of the vehicle has to be changed to match with motorcade sequence which is black.
- 7. <u>Cameras:</u> The Cameras provided with base vehicle are meant for smooth maneuvering of the vehicle. Additional security cameras for 360 degree view with recording facility must be installed in BR vehicle and covered for any projectile damage by the stone etc.

8. <u>Fabrication Drawings:</u> The fabrication drawing shall be vetted/cleared before approval for fabrication is accorded. The drawing must be supported with scientifically calculated data indicating power/weight ratio, visibility, size, specification etc.
