**Subject:- Grant of Special welfare Relief in favour of NoKs of deceased Police Personnel**

**ORDER NO: 3315 OF 2023**  
**DATED: 28.11.2023**

i- Whereas, welfare loan of ₹1,50,000/- (Rupees one lakh fifty thousand only) out of Central Police Welfare Fund vide PHQ Order No.767 of 2023 dated 09.03.2023 was sanctioned in favour of Constable Mohammad Younus No.547/17<sup>th</sup>, PID No.ARP169286 of IRP 17<sup>th</sup> Bn, in connection with self treatment.

iii- Whereas, said Constable expired due to illness on 16.09.2023 at SMHS Hospital, Srinagar, while in service and ₹1,05,000/- (Rupees one lakh five thousand only) remained outstanding against the deceased.

In light of the above and in pursuance to Rule-3(e) (Loans) clause-v of Revised Welfare Fund Rules 6<sup>th</sup> Edition 2018, sanction is hereby accorded to the:-

- Conversion of ₹50,000/- (Rupees fifty thousand only) out of un-liquidated welfare loan amount into relief.
- Re-imbursement of ₹1,00,000/- (Rupees one lakh only) to CO, IRP 17<sup>th</sup> Bn already paid by him to NoKs of the deceased Constable as immediate relief.
- Grant of Special Welfare Relief of ₹20,45,000/- (Rupees twenty lakh forty five thousand only) out of Contributory Police Welfare Fund in favour of dependents/actual legal heirs of deceased, deficit by ₹55,000/- (Rupees fifty five thousand only) un-liquidated welfare loan amount.
- Drawal of ₹55,000/- (Rupees fifty five thousand only) out of Contributory Police Welfare Fund, to be credited to Central Police Welfare Fund.
