ORDER NO **551** OF 2025

This order is being issued to decide the claim of Shri Inder Pal s/o Shri Kuldeep Singh r/o Janglote Tehsil & District Kathua for compassionate appointment, under SRO 43 of 1994, in lieu of death of his brother namely Late Constable Vinod Singh No 1809/J PID No EXJ 016172.

Whereas, Constable Vinod Singh expired on 23-09-17, while in service, during his posting in Traffic Wing of J&K Police, leaving behind his wife, two daughters, son and a brother.

Whereas, on 06-01-18 IG Traffic had forwarded an application of Smt Meena Devi w/o Late Constable Vinod Singh to this HQ with the request that the benefit of compassionate appointment in favor of the applicant's son namely Suryansh Jasrotia may be reserved, till he attains the age of eligibility for Govt. Service under SRO-43 of 1994.

Whereas, the case of Shri Suryansh Jasrotia, son of the deceased official, was examined at this HQ and it was found that his Date of Birth is 31-07-2010 and as such his age was only 07 years 01 month and 22 days at the time of death of his father. Thus, being a minor, he was not eligible for compassionate appointment as per the provisions of SRO-43 of 94 read with SRO 177 of 14 dt 20 Jun 14.

Whereas, in view of ineligibility of the deceased official's son, Traffic HQ, vide this office letter dt 24-01-18, was requested to process the compassionate appointment case of wife of the deceased, being prime beneficiary in the case.

Whereas Traffic HQ, vide letter dt 17-11-21, conveyed that Smt Meena Devi, wife of the deceased official, has appeared before SSP Traffic Jammu and

requested that her brother-in-law namely Shri Inder Pal s/o Shri Kuldeep Singh may be considered for appointment as Follower under SRO 43 of 94.

Whereas, the case of Shri Inder Pal was received without necessary documents, as such Traffic HQ, vide letter dt 11-04-22 was requested to furnish requisite documents for further course of action.

Whereas, verification of character and antecedents of Shri Inder Pal revealed that he has been residing in Ranipur Thinga, district Pathankot, Punjab for the last 25 years and as such a report with regard to his character and antecedes was sought from Punjab Police, which revealed that there is nothing adverse against him in records of Police Station Shahpur Kandi, Pathankot, Punjab.

Whereas, the proposed beneficiary namely Shri Inder Pal had furnished a Secondary School Examination Certificate, issued by National Institute of Open Schooling (NIOS), as proof of qualification. Moreover, during verification of the Certificate, it was learnt that he has not qualified the said examination, as such SSP traffic City Jammu was requested to provide an alternate proof of qualification of the proposed beneficiary.

Whereas, SSP Traffic City Jammu vide letter dt 24 Dec 24 intimated that the proposed beneficiary has submitted an alternate proof of his qualification, a Secondary School Examination Certificate issued by Grameen Mukt Vidhyalayi Shiksha Sansthan (GMVSS) Delhi, which as per clarification sought from the Board of School Education Jammu, is not listed in the recognized board of the country, as published by the Department of School Education Literacy, Ministry of Education, Govt. of India.

Whereas, the proofs of educational qualification submitted by the proposed beneficiary Shri Inder Pal are invalid for aforementioned reasons, besides he has been residing in residing in Ranipur Thinga, Pathankot, Punjab for the last 25 years, even before death of his brother, which in itself means that he has adequate means of sustenance at his present place of residence.


Whereas, in light of the above enumerated facts and circumstances and in compliance to the Hon'ble CAT Order dt 19 Oct 24, the case of the applicant is unjustifiable and devoid of merit, thus merits rejection. However, keeping in consideration the principle of compassion and to take care of the welfare of

the families of deceased police officials, case of another eligible dependent may be processed for compassionate appointment under rules in vogue.

Now, therefore, having due regard to the directions of Hon'ble CAT and circumstances of the cases together with the rules/policy governing the field, claim of the applicant namely Shri Inder Pal b/o late Const Vinod Singh r/o Janglote Tehsil and Distt Kathua being not maintainable is hereby rejected on merits.

I. The applicant be informed accordingly.
