fake/forged, or if a satisfactory report with regard to character and antecedents of the appointee is not received, the claim of the appointee for appointment as Constable in J&K Armed Police shall be deemed to have been cancelled ab initio and legal action warranted under rules shall be initiated against him.

d. The appointment of the candidate shall be governed by the New Pension Scheme, as per SRO 400 of 2009, dt 24 Dec 09.

e. If the appointee fails to join **within a period of 21 days**, from the date of issuance of this order, he shall forgo his right to appointment and the appointment shall be deemed to have been cancelled, without any further notice.
