Sanction is accorded for the temporary appointment of Shri Sikam Singh s/o Late Constable Puran Singh No. 703 JKAP 13 Bn r/o Vill Chancer, Tehsil Bhalessa (Gandoh), Distt Doda, as Follower in J&K Armed Police in the Pay Level of SL1(14800-47100), in terms of SRO 43 of 1994, read with SRO 376 of 2017, dt 11 Sep 17.

The appointee shall report to ADG Armed Police, **within a period of 21 days**, from the date of issue of this order, alongwith the following documents/certificates, in original, to be verified subsequently:

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the Police Hospital.
- v. Dependent Certificate issued by Assistant Commissioner Revenue.
- vi. All other relevant documents as are required under SRO 43 of 1994.


The appointment of **Shri Sikam Singh** as Follower shall be subject to the following conditions:

- a. The formal appointment order shall be issued after fulfillment of all procedural formalities, as required under SRO 43 of 1994 and extant rules.
- b. The formal appointment order shall be issued only after receipt of satisfactory Character & Antecedents Report, in favour of the

applicant, from CID and genuineness of qualification and other certificates from concerned issuing authorities.

- c. That the appointee shall give an undertaking, through an affidavit to the effect that if, on verification, genuineness of documents/certificates from the concerned issuing authority is found to be fake/forged, or if a satisfactory report with regard to character and antecedents of the appointee is not received, the claim of the appointee for appointment as Follower in J&K Armed Police shall be deemed to have been cancelled ab initio and legal action warranted under rules shall be initiated against him.
- d. The appointment of the candidate shall be governed by the New Pension Scheme, as per SRO 400 of 2009, dt 24 Dec 09.
- e. If the appointee fails to join **within a period of 21 days**, from the date of this order, he shall forgo his right to appointment and the appointment shall be deemed to have been cancelled, without any further notice.
