ORDER

**Sub: Blacklisting of M/S Sethiya Enterprises 308, Lordganj Jabalpur,
Madhya Pradesh-482002**

1. Where-as Police HQ J&K has purchased 300 Hand Held Search Lights "Make and Model Onlite" M/S Sethiya Enterprises Pvt Ltd at a unit cost of Rs 1498.50 against supply order nr GEMC-511687792573739 dated 28 March 22 and GEMC-511687762169637 dated 29 March 22.
2. Where-as these Hand Held Search Lights were allotted to subordinate units in view of SANJY 2023. The supplied Hand Held Search Lights were found faulty and accordingly said firm was requested vide HQ letter no Prov-II/Sec-56/2021-22/7564-65 dt 8 Sept 23 to depute technicians/experts to J&K for making necessary repairs/replacement of Hand Held Search Lights.
3. Where-as vide this HQ letter no Prov-II/Sec-56/2021-22/2018-23 dt 15 Feb 24 and letter no Prov-II/Sec-56/2021-22/3742 dt 3 April 24 M/S Sethiya Enterprises Pvt Ltd was again asked to depute technician(s) to Police Component Jammu/Police Central Store Jammu for making these Hand Held Search Lights functional, but neither the firm deputed technician(s) nor any written communication was received from said firm.
4. Where-as M/S Sethiya Enterprises Pvt Ltd has not responded to these communications sent by this HQ and accordingly HQ raised incident vide nr 1893779 and 1893774 against said firm on 25 May 24 on GeM which was escalated on 05 June 24.
5. Where-as on 10/06/2024 Police Central Store Gulshan Ground Jammu received 40 batteries for 20 faulty Hand Held Search Lights from said firm through courier.
6. Where-as vide this HQ letter no Prov-II/Sec-56/8146-70 dated 24 June 24 asked M/S Sethiya Enterprises Pvt Ltd to inspect all 300 Hand Held Search Lights which were supplied by said firm and subsequently allotted by HQ to subordinate units of J&K Police and make them functional on urgent basis, which may include repairs/replacement of batteries, wherever required, to the satisfaction of end users, under intimation to this HQ J&K.

7. Where-as this HQ letter no Prov-II/Sec-56/2021-22/10725-40 dated 21 Aug 24 given last opportunity to said firm to make the non-functional Hand Held Search Lights functional within 10 days, but as on date neither said firm replied communications of this HQ nor repaired non-functional HHSL.
8. Where-as on 27 Sept 24 this HQ again escalated incidents raised already on GeM against the firm, but the firm again failed to make HHSL functional.
9. Where-as as per bid clause-7 (ATC), the item is under warranty for period of three years with effect from 27 July 22 to 26 July 25 and said firm is bound to make these search lights functional within warranty period.
10. Whereas the firm M/S Sethiya Enterprises has failed to fulfill contractual obligation, as such, the firm is liable for administrative action such as suspension/debarment/removal.
11. Therefore in view of above facts it is ordered that:

M/S Sethiya Enterprises 308, Lordganj, Jabalpur, Madhya Pradesh-482002 is hereby **blacklisted** for a period of two years from the issuance of this order.
