ORDER NO 1881 OF 25

Sanction is accorded for the temporary appointment of Shri Abdul Rahim s/o Late ASI Abdul Qayoom No 851 NGO SDRF 2 Bn, PID No EXE882543 r/o Vill Nerojal, Tehsil Thannamandi, Distt Rajouri, as Constable in J&K SDRF, in the Pay Scale of Level 2 (19900-63200), in terms of SRO 43 of 94, read with SRO 177 of 14 dt 20 Jun 14.

The appointee shall report to Commandant General HG CD and SDRF, **within a period of 21 days**, from the date of issue of this order, alongwith the following documents/certificates, in original, to be verified subsequently:



- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the Police Hospital.
- v. Dependent Certificate issued by Assistant Commissioner Revenue.
- vi. All other relevant documents as are required under SRO 43 of 94.

The appointment of **Shri Abdul Rahim** as Constable shall be subject to the following conditions:

- a. The formal appointment order shall be issued after fulfillment of all procedural formalities, as required under SRO 43 of 94 and extant rules.
- b. The formal appointment order shall be issued only after receipt of satisfactory character & antecedents report in favour of the applicant from CID and genuineness of qualification and other certificates from concerned issuing authorities.

AS

- c. That the appointee shall give an undertaking through an affidavit to the effect that if on verification, genuineness of documents/certificates from the concerned issuing authority is found to be fake/forged or if a satisfactory report with regard to character and antecedents of the appointee is not received, the claim of the appointee for appointment as Constable in J&K SDRF shall be deemed to have been cancelled ab initio and legal action warranted under rules shall be initiated against him.
- d. The appointment of the candidate shall be governed by the New Pension Scheme, as per SRO 400 of 09 dt 24 Dec 09.
- e. If the appointee fails to join **within a period of 21 days**, from the date of this order, he shall forgo his right to appointment and the appointment shall be deemed to have been cancelled without any further notice.
