## Annexure "A"

### TERMS AND CONDITIONS

1.	The chartered Accountant Firm should be the Member of Association of Chartered Certified Accountants (ACCA)
2.	The Firm has to submit self-certified copy of valid Pan Card of the Firm.
3.	The Firm has to submit self-certified copy of GST Registration Certificate.
4.	The Firm has to submit self-certified copy of empanelment letter of Comptroller and Auditor General of India (CAG).
5.	The Firm has to submit self-certified copies of the IT Returns of the Firm/full time partners/Sole proprietor / others as the case may be for the last three years.
6.	The CA Firm must have their Head Office or Branch office in Jammu or Srinagar. The Firm has to submit self-certified copy of ownership of Office/ Rent agreement with electricity bill as proof. The Firm shall ensure that their services are readily available at all times to PHQ J&K and representative of the firm shall visit PHQ twice a week (working days).
7.	The Firm shall submit an affidavit to the effect that they have neither been blacklisted nor debarred by any authority.
8.	The Firm should have at least 5 years experience in Finance, Banking and Management.
9.	The Firm should have ability to interpret figures and information, strong analytical and problem resolving ability.
10.	The Firm shall have to sign a service agreement on non judicial stamp paper worth Rs.100/- duly attested by Executive Magistrate.
11.	The successful bidder will have to deposit security amount of Rs.20000/- (Rupees twenty thousand only) in the shape of CDR/FDR pledged to AIG (Welfare) PHQ. The security deposit shall be refundable after the culmination of contract.
