ORDER NO 673 OF 25

Whereas, SI(Tel) Ghulam Hussain No 1215/PW TEL 846250 among other batch mates was considered by DPC on 11 Jun 20, for being brought on Promotion list "F" of Telecom Cadre.

Whereas, during scrutiny of records, it was found that the subject was involved in case FIR No 23 of 2019, U/S 354-B, 452, 504 & 506 RPC of P/S Kandi Rajouri, as such, sealed cover procedure was adopted and recommendations of DPC in respect of SI(Tel) were kept in sealed cover.

Whereas, the sealed cover was reviewed during subsequent DPCs on dt 23 Oct 21 & 28 Nov 23, and in both occasions it was recommended to be continued as the criminal case was still sub judice.

Whereas, in 2024, Telecom HQ vide lr no Estt/PF-1215/2024/3196, dt 22 Mar 24, communicated that FIR No 23 of 2019, has been dismissed by the Hon'ble Principal District and Sessions Judge, Rajouri vide order dt 31 Oct 23 and the DE against said SI (Tel) has also been finalized by Telecom HQ vide Order No 70 of 2024, dt 14 Feb 24, wherein the subject was exonerated from the charges leveled against him.

Whereas, a report was sought from Telecom HQ as to whether any appeal was filed against order dt 31 Oct 23 passed by Hon'ble Principal District and Sessions Judge Rajouri, and in response, Telecom HQ vide lr no Estt/PF-1215/2024/8875-76, dt 21 Aug 24, intimated that no appeal has been filed against the above mentioned order dt 31 Oct 23, and the Judgment has been treated as final.


Whereas, consequent upon above, sealed cover proceedings are required to be opened and acted upon and after opening of sealed cover, the recommendations of DPC, dt 23 Oct 21, are as under:

"On his exoneration from the criminal case presently pending adjudication in the court of law and after obtaining fresh clearances from ACB, CIV and the Deptt. he may be considered for next promotion in continuation to the recommendations of this DPC. Till then the DPC proceedings in his case be kept in sealed cover".

Whereas, as per the recommendations of the DPC, fresh ACB, CIV and Departmental NIC was obtained from DPT J&K vide lr no ESTT/PL-F-45/2022/542-43, dt 14 Jan 25.

Therefore, while taking into account above said facts and circumstances, SI (Tel) Ghulam Hussain TEL 846250 is promoted to the rank of Inspector (Tel) in the pay level 6E(₹35900-113500) with effect from 27 Oct 21 ie the date his immediate junior was promoted, with all consequential benefits. He is placed between serial no 35 SI (Tel) Kuldeep Singh No Tel 836144 & serial no 37 SI (Tel) Fayaz Ahmad No TEL822235.

This order is issued without prejudice to the writ petition(s), if any, pending in any competent Court of Law.
