ORDER NO 296 of 25

Sub: Selection for the post of Sub Inspector from the waiting list.

Whereas, in terms of this HQ Order No 3221 of 24, dt 21 Nov 24, 19 candidates (14 under Open Merit, 02 under ST, 02 under SC and 01 under EWS category) were selected for the post of Sub Inspector in J&K Police, after the operation of waiting list.

Whereas, the candidates were subsequently informed to report at their respective Range HQ for issuance of their formal appointment orders subject to fulfillment of prescribed formalities.

Whereas, the candidates selected were advised to present themselves in the offices of their concerned Range DIsG, along with requisite testimonials, for fulfillment of prerequisite formalities, prescribed for issuance of formal appointment orders, within 21 days.

Whereas, ADG Jammu Zone, vide lr no Pers/PSI-2024/370-72, dt 4 Jan 25, has intimated that candidate namely Rashad Sadiq, s/o Mohd Sadiq, r/o Gulpur, Tehsil Haveli, District Poonch, who was selected as Sub Inspector under ST category (after operation of waiting list figuring at S No 2), has expressed unwillingness, in writing, to join the department as he has been selected elsewhere.

Whereas, in view of the facts enumerated above, selection of Rashad Sadiq, s/o Mohd Sadiq, r/o Gulpur, Tehsil Haveli, District Poonch, who is unwilling to join the Police Department, is hereby ordered to be cancelled ab inito.


Whereas, consequent upon the above and considering the vacancy that has remained unfilled, as a result of cancellation of selection of 'unwilling' candidate named above, it has become necessary to bring the waiting list, issued vide JKSSB ltr no & date cited above, into operation, for filling up the vacancy.

Now, therefore, taking into consideration the above facts, candidate namely **Tanveer Ahmed, s/o Mr Mohd Latief, r/o Hubbi, p/o Kandi, Tehsil Kotranka, District Rajouri** figuring in the waiting list at S No 3 under ST category being eligible by virtue of prevailing rules is selected as PSI subject to the following conditions/formalities:

- i. The selection of candidate after the operation of waiting list shall be subject to outcome of the OAs/Writ Petitions(s), if any, pending adjudication before any competent Court of law.
- ii. The selection shall also be subject to the outcome of any inquiry, involving candidate mentioned in the order.
- iii. Verification/authentication of genuineness of testimonials of the selected candidate.
- iv. Verification of reserved category certificate.
- v. Verification of character/antecedents from CID.
- vi. Medical examination/checkup from Police Hospital, Jammu.

The selected candidate shall report to the concerned Range DIG, along with his original testimonials, within 21 days from the date of publication of this order, for issuance of his formal appointment orders, failing which the selection shall be deemed to have been cancelled without any further notice.

This order is issued without prejudice of the outcome of any OAs/Writ Petitions(s), if any, pending adjudication before any competent Court of Law.
