




ORDER NO 3489 OF 24

IGP Technical Services Hqrs vide lr No PA/Tech/2024/2115, dt 08 Aug 24, intimated that:

- a) Dr. Ahraz Rehman Wani had fraudulently got the fingerprint of Sgct Sheeraz Ahmad registered as his own, so as to get his attendance marked in the biometric attendance system at Police Hospital Srinagar.
- b) With the help of CCTV, installed, the fraud being played by Dr. Arhaz Rehman Wani, in connivance with Sgct Sheeraz Ahmed PID No TEL107149 and Sgct Muneer Ahmad PID No EXK118924, got detected.

Consequent upon the above, a preliminary enquiry was ordered by Medical Superintendent of Police Hospital Srinagar against Sgct Sheeraz Ahmed PID No TEL107149 and Sgct Muneer Ahmad PID No EXK118924 (then posted in Police Hospital Srinagar) for their involvement in misconduct and manipulation of attendance record, by misusing the Bio-metric attendance system installed in Police Hospital Srinagar. During departmental enquiry prima facie misconduct was made out by the Medical Superintendent Police Hospital Srinagar against trio and Dr. Ahraz Rehman wani was placed under suspension by Govt. Health & Medical Education Department vide Order No 487-JK(HME) of 2024, dt 30 July 24.

Since two police officials viz Sgct Sheeraz Ahmed PID No TEL107149 and Sgct Muneer Ahmad PID No EXK118924 are also involved in the misconduct as such, a regular Departmental Enquiry is also ordered against them and is entrusted to DIG Armed Range Srinagar (Administrator Police Hospital Srinagar), who shall complete the same within 02 weeks and shall submit his finding with specific recommendations to HQ.
